### **Bonds Purchased by Institutions in Auctions**

In the auction for the Series 2000 Bonds on April 8, 2008, the Institutions purchased \$23,225,000 principal amount of bonds in the auction.

In the auction for the Series 2002 Bonds on April 9, 2008, the Institutions purchased \$200,000 principal amount of bonds in the auction.

As a result, the Institutions now hold \$139,525,000 principal amount of the Series 2000 Bonds and \$33,200,000 principal amount of the Series 2002 Bonds.

### **Bidding at Future Auctions**

The Institutions have determined that commencing with the auctions for the Series 2000 Bonds and the Series 2002 Bonds on April 15, 2008 and April 16, 2008, respectively, the bids submitted by the Institutions to purchase the Bonds will be based on (until further notice) one week LIBOR plus a spread of 0.25%.
